2026 Utility Rate Changes

During the January 12, 2026 Council Meeting, Town Council passed Bylaw 841/2026, the Utility Bylaw. As the Town continues working towards a cost recovery focus for utilities, there are small changes to the rates for this year.

Resident feedback about sewer charges has been taken into consideration and the Bylaw has a reduction in sewer rates for any water consumption above 30 cubic meters (m³). This reduction is only applicable to the volume of use above 30 m³.

The introduction of this reduced rate for higher volume users provides sewer rate relief for anyone using larger amounts of water for things like watering lawns, filling pools, etc.

The new rates are now in effect and are reflected on the January 2026 utility bills.

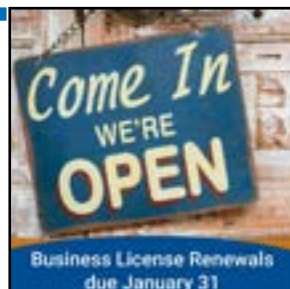
Business License Renewals

Calling all business owners, contractors, home-based businesses, and any person(s) who performs services or advertises products within Penhold. Your 2026 Business License renewal must be paid by Jan. 31.

Businesses not renewing by the due date will incur a 15% Penalty Fee on February 1.

All businesses without a valid business licence, after January 31, will be removed from the Business Directory on the town website.

Each business license is valid during a calendar year. Operating without a valid business license carries a fine of \$400.00. You can learn more about business licenses, renew your existing license or apply for a new one on the Town of Penhold website.

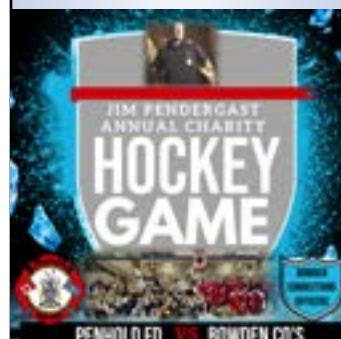

Snowmobiling Is Prohibited Within Town Limits



Residents are reminded that snowmobiling is not permitted within town limits, including all green spaces. This restriction is in place to ensure the safety and enjoyment of these spaces for all residents and to protect the integrity of our shared community resources.

Why snowmobiling is not allowed:

Legal Restrictions: Operating snowmobiles within Penhold town limits violates Bylaw 828/2024. (Section 4.9 restricts parking and driving of any vehicle, including snowmobiles, on Town land.)

Preventing Damage to Park Resources: Snow-covered areas may conceal small trees, shrubs, grass, park furniture, and infrastructure. Snowmobiles can cause significant damage to these elements, which are vital to maintaining the beauty and functionality of our parks.

Ensuring Safety for People and Pets: Parks are often used by pedestrians, families, and pet owners during winter months. Snowmobiles pose a risk of harm or negative interactions with individuals enjoying these spaces on foot.

We appreciate your cooperation in respecting these guidelines. Let's work together to ensure our parks remain safe and beautiful for everyone to enjoy. If you have any questions, please contact the Town Office.



Keep sidewalks clear of ice and snow

Penhold is an active community, please help everyone stay safe while they are enjoying the outdoors by clearing your sidewalks quickly after it snows. Snow must be removed within 72 hours of any snowfall. Please remember, snow cleaned off sidewalks and driveways cannot be deposited onto the road.

During warmer weather with melting and freezing, please make sure your walkways are clear of ice as well.

If you see a "Snow Angels Welcome" sign, please consider helping your neighbour with their snow / ice removal.
