Purchase Your 2026 Pet License Before December 31 & Save Money!



If you have an existing Town of Penhold Pet License, you are eligible for the Early Renewal discount if you renew your Pet License before December 31.

If Licenses are renewed October 1 to December 31 the following rates apply:

Unaltered Animal: \$30 Altered Animal: \$15

After December 31 the following rates apply:
Unaltered Animal: \$60
Altered Animal: \$45

Tag replacements are \$10. New tags are not required with renewals.

Renewing your Pet License is quick and simple through the Town of Penhold website or you can stop by the Town Office Monday through Friday 8:30 a.m. - 4:30 p.m. (closed 12:00-12:30 for lunch).



The Operations team will be picking up Christmas trees starting Jan. 5.

If you would like your tree picked up please ensure the following:

- Your tree is free of all decorations including tinsel and is NOT bagged
- Place the tree on your front lawn on or before 8:00 a.m. on Monday January 5.

Storm Ponds are NOT SAFE for Recreation

Unlike regular ponds in the rural areas, the storm retention ponds can have water flowing into these systems anytime during the winter months. Our recent warm weather caused melting, the run off is flowing under the ice of all the storm ponds in Penhold.

These storm retention ponds will not be measured for ice depth. For everyone's safety, please remember the danger of thin ice means storm ponds are not safe for people or pets.



The Community Hub Pond Aeration system runs year-round and assists with the natural oxygenation process of the water body to help combat harsh winter conditions. This will result in open water and thin ice throughout the winter.

Outdoor Rink Update

We know everyone is excited for the Outdoor Rink (ODR), at Lincoln Street Recreation Area, to open for the season. They are working hard to get the ice ready for everyone to enjoy.

Unfortunately, the Operations Department has been in a dance of one step forward and two steps back with Mother Nature. Each time they get a good base started, the weather warms up and the work melts away.

Please stay off the ice until the lights are on indicating the ODR is open. Check the Town website and social media for more info about the opening date of the outdoor rink.





E-Billing for Utility Bills & Property Tax Assessments

All utility customers and property owners are encouraged to consider signing up for E-Billing to receive their monthly bills and annual combined Property Tax Assessment and Notices via email.

Benefits of E-Billing include:

- Secure access to your billing and payment history online
- Receive your bill as soon as it is prepared instead of waiting for mail
- Help the environment by reducing the demand for paper
- Cost savings

Signing up for E-Billing can be done through the Town of Penhold website using a copy of your current bill, or property tax assessment, which has your Access Code / PIN ID available on it.
