Location

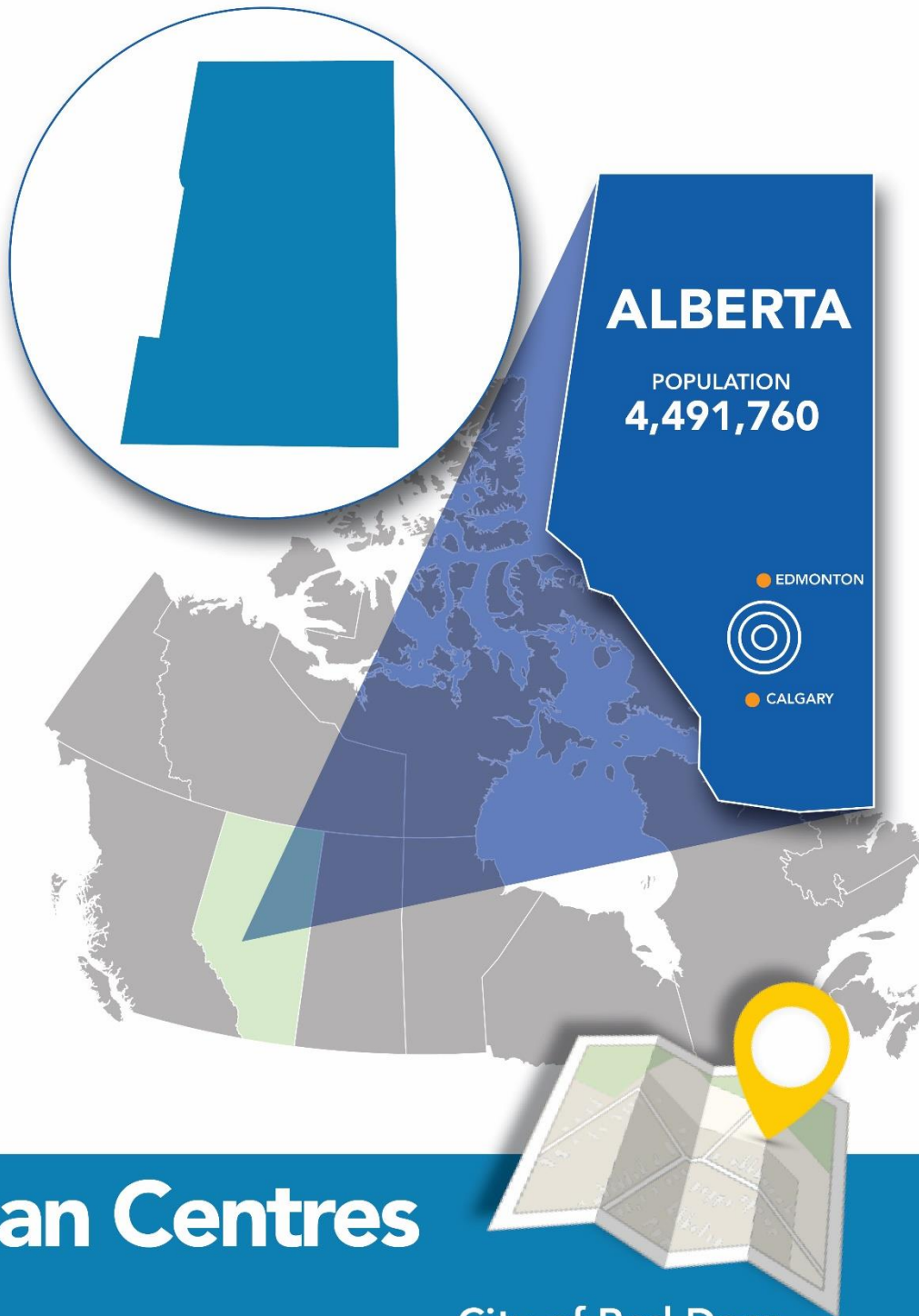
Penhold is a town in central Alberta, Canada. Penhold is surrounded by the county of Red Deer No. 23, 15km south of Red Deer at the junction of Highway 2A and Highway 42. It is located 128 km north of Calgary.

Originally, Penhold was one of the many whistle stops along the Canadian Pacific Railway. It incorporated as the Village of Penhold in 1904.

In 1980, the Village of Penhold incorporated as a town as a result of large population growth in the late 1970s.

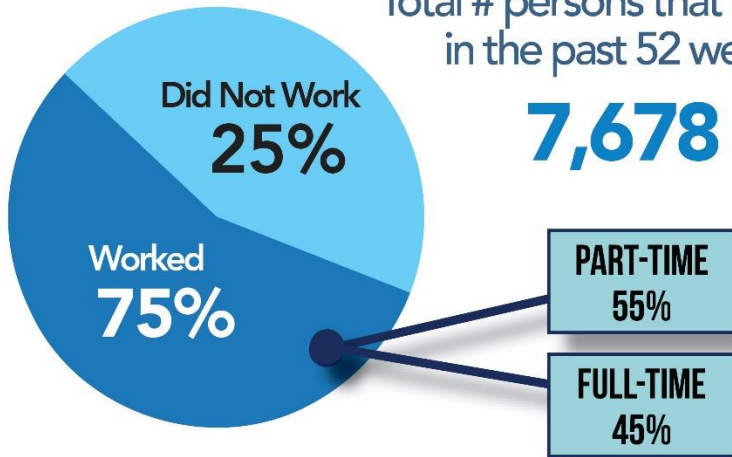

DATA SOURCES

Please note that every effort has been made to use the most current data available. The major sources of information for this document are:

- The 2006, 2011, 2016, and 2021 Census from Statistics Canada;
- Manifold SuperDemographics data is 2022 from Manifold Data Mining Inc.; and
- EMSI Analyst Data.



The most recent Census was conducted in 2021. Though most data has not yet been released from this Census, population figures have been updated and included in this document. SuperDemographics 2022 is the most up to date estimation of population characteristics, based on mathematical models that draw from various data sources.

Manifold Projection Method

Manifold estimates demographic data annually, including population projections for 5 and 10 years in the future. Manifold methodologies are based on the following techniques:

- Enhanced cohort survival methods;
- Nearest neighborhood and regression techniques; and
- Structural coherence techniques.

1. INTRODUCTION

A Great Place to Call Home!



Penhold was incorporated as a village in 1904. In 1940 a Royal Canadian Air Force Manning Depot opened near Penhold (RCAF Station Penhold) and created a flight training school as part of the British Commonwealth Air Training Plan from 1941 to 1944. From 1966, facilities of the former base were leased by the Royal Canadian Air Cadets as the Penhold Air Cadet Summer Training Centre, until it was closed in 2014.

Penhold has remained a clean, modern and family-orientated community which attracts new residents from across Central Alberta and the rest of Canada. With incredible population growth, Penhold is rapidly living up to its motto, "The Home of Future Generations". Its continued growth and expansion is linked to its proximity to Red Deer and major transportation routes.

The Home of Future Generations

Penhold has approximately 1,068 hectares of available land for development and new opportunities which offer unique land value opportunities to investors.

Penhold has the main Canadian Pacific north/south rail connector running adjacent to its industrial lands, and offers access to highways, rail and air transportation in close proximity.

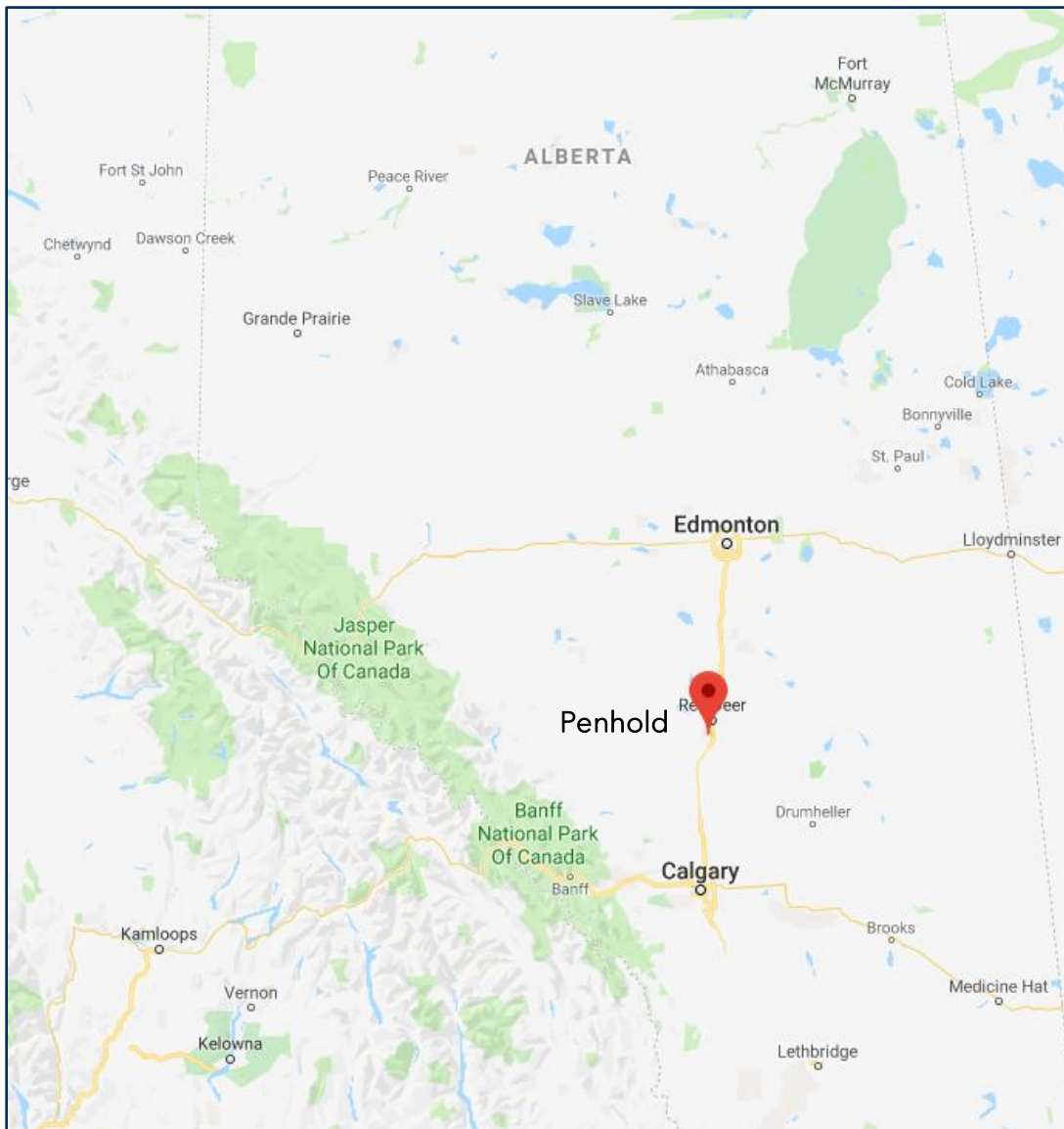

1.1. Location

Penhold is situated along Highway 2A between Alberta's two most populated urban communities, Calgary and Edmonton, and just 15 kilometers South of Red Deer. Penhold is situated between several major highways including Highway 2A, Highway 42 and Highway QEII, all of which provide access into the community. Penhold is ideally located along the CP Main Rail Connector.

1.2. Climate

Town of Penhold climatic data was retrieved from the Government of Canada's Nearest Environment Canada Station. The most recent longitudinal information presents data from 1981-2010. Table 1 and Figure 2 illustrate precipitation levels, average and extreme temperatures.¹

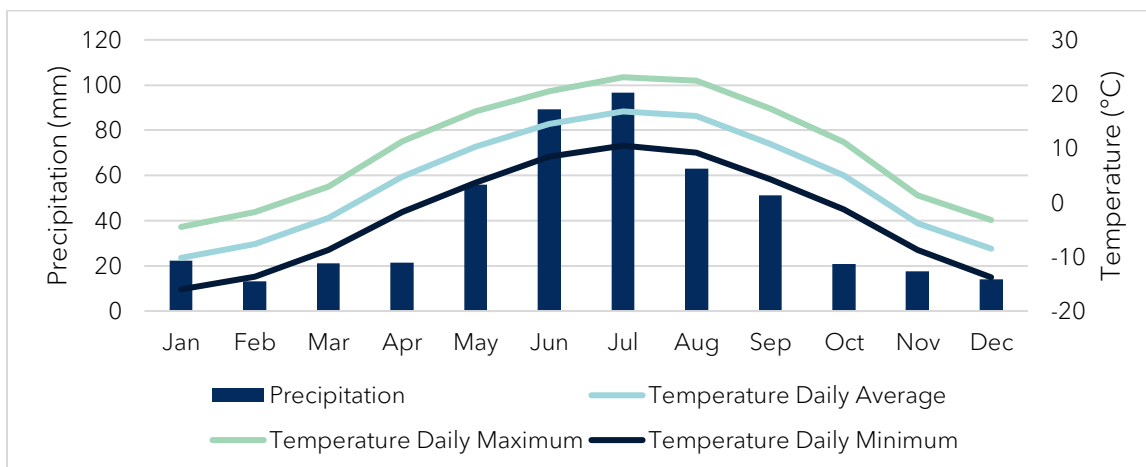

¹ The most recent data available for climate averages is from 1981-2010. As these data are averages across 30 years, the general trendlines can be expected to hold in more recent years.

2. DEMOGRAPHICS

2.1. Population Size and Growth

Between 2011 and 2021, the census population in Penhold grew dramatically from 2,375 individuals to 3,484 (see Table 2) an increase of approximately 1,109 residents. While the next decade is not expected to see similar double digit growth rates, substantial growth is nevertheless expected to continue. Specifically, by 2032 population estimates suggest Penhold will exceed 4,000 residents (4,273).²

These figures represent the total population *for that statistic* – reliable data for those figures may not be available for the entire population and therefore use a slightly smaller sample size.

³ Data for Table 1 projections rely on Manifold estimates. We are aware that other Town documents and projections (including those from the Alberta Treasury Board noted on Penhold’s Snapshot, above) suggest different figures. However, this document relies on Manifold data throughout and in order to compare similar figures throughout, we rely on that data here as well. Please note, these population projections should not be directly compared with other sources’ population figures.

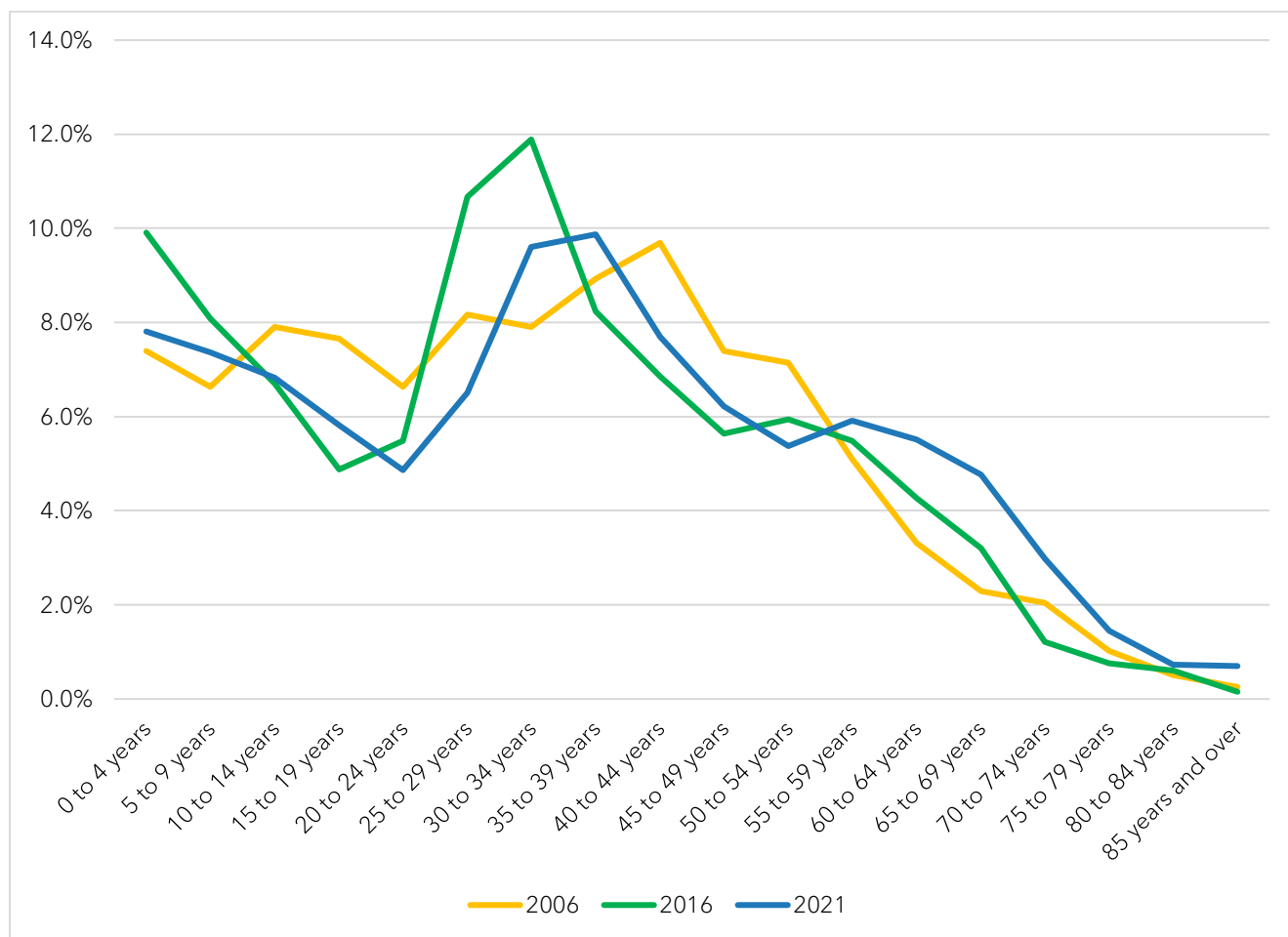
2.2. Age Profile

Figure 3 illustrates changes to Penhold's population by age, over the past 15 years.

Penhold's population has gotten older over the previous 15 years, with its share of youth (ages 0-29) decreasing from 44.4% in 2006 to 39.2% in 2021. Moreover, its population of older adults (60+) has increased from approximately 1-in-10 residents (9.4%) in 2006 to approximately 1-in-6 (16.1%) in 2021. This shifting dynamic will create new opportunities related to the needs of the population, suggesting that a differing approach to community engagement may be needed in the coming years to adjust for this demographic breakdown.



Figure 3: Age Distribution Chart, Town of Penhold, 2006-2021

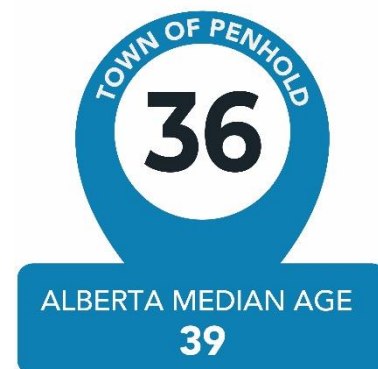
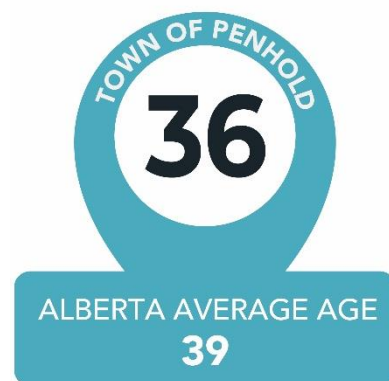

2.3. Income

Table 4 shows the breakdown of total individual incomes in 2021⁴. In 2021, median total income for all Penhold residents 15 years and over was \$62,667. Over half (54.5%) of residents earned over \$50,000 in 2021, and 21.0% of residents earned over \$90,000.



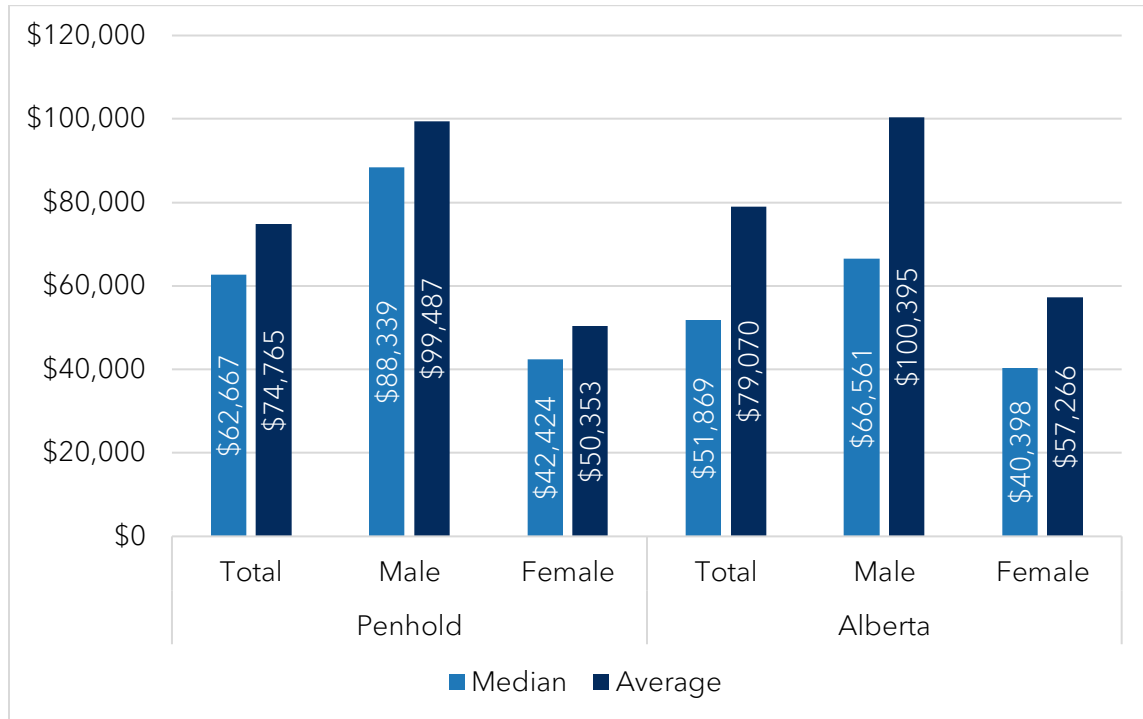

Table 5 illustrates that median and average household income in Penhold are comparable to Alberta figures more broadly. While Median household total income is slightly higher (3.4%), average income is 6.0% lower. Similarly, across both jurisdictions, just over half the population earns \$100,000 or more.

2.4. Mobility Characteristics

Penhold residents were slightly more likely to change place of residence within one or five years, relative to Alberta residents. Specifically, over the last five years 52.6% of Penhold residents had moved, compared to 46.7% of Albertans (Table 6).

⁵ Refers to the relationship between a person's usual place of residence on Census Day and their usual place of residence one year earlier. A person is classified as a non-mover if no difference exists. Otherwise, a person is classified as a mover and this categorization is called Mobility status (1 year ago). Within the category of movers, a further distinction is made between non-migrants and migrants; this difference is called migration status.

⁶ Non-movers are persons who, on Census Day, were living at the same address as which they resided one year earlier.

⁷ Movers are persons who, on Census Day, were living at a different address from the one at which they resided one year earlier.

⁸ Non-migrants are movers who, on Census Day, were living at a different address, but in the same census subdivision (CSD) as the one they lived in one year earlier.

⁹ Migrants are movers who, on Census Day, were residing in a different CSD one year earlier (internal migrants) or who were living outside Canada one year earlier (external migrants).

2.5. Language Characteristics

Table 7 indicates knowledge of Canada's official languages. Only 0.1% of Penhold residents speak 'neither English nor French', less than the provincial figure (1.5%). The rate of French-speakers in Penhold is also less than the provincial mark, with 1.3% speaking either French, or both English and French (6.7% do so provincially).

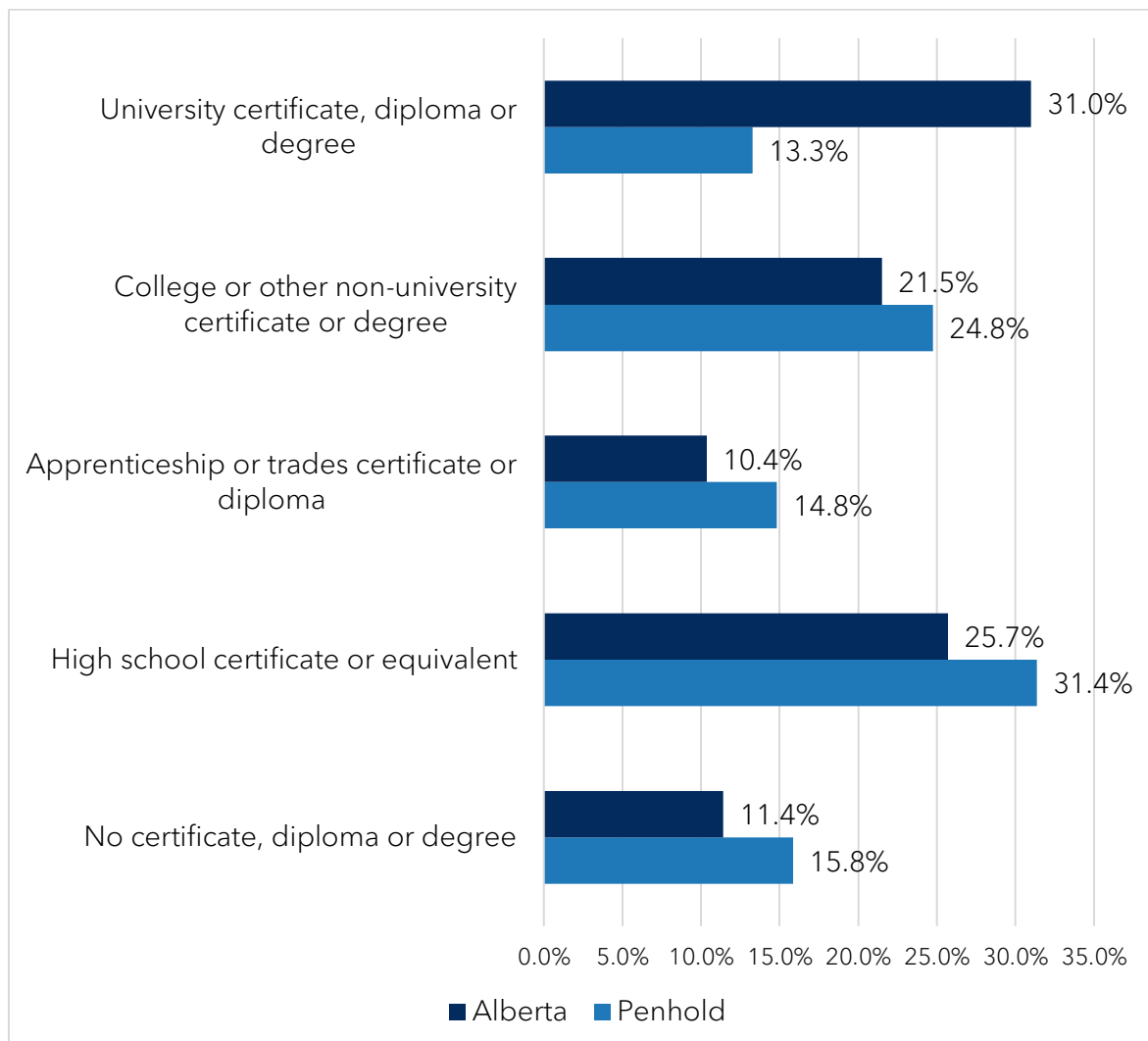
2.6. Level of Education

Figure 5 illustrates educational attainment for residents ages 25 to 64 in Penhold and Alberta. While Alberta's population is more likely to have attained a university certificate, diploma or degree, Penhold residents are more likely to have a *college or other non-university certificate or degree, or apprenticeship or trades certificate or diploma*.



Approximately two in five (39.6%) of Penhold residents have either a "college or other non-university certificate or degree" or "apprenticeship or trades certificate or diploma."

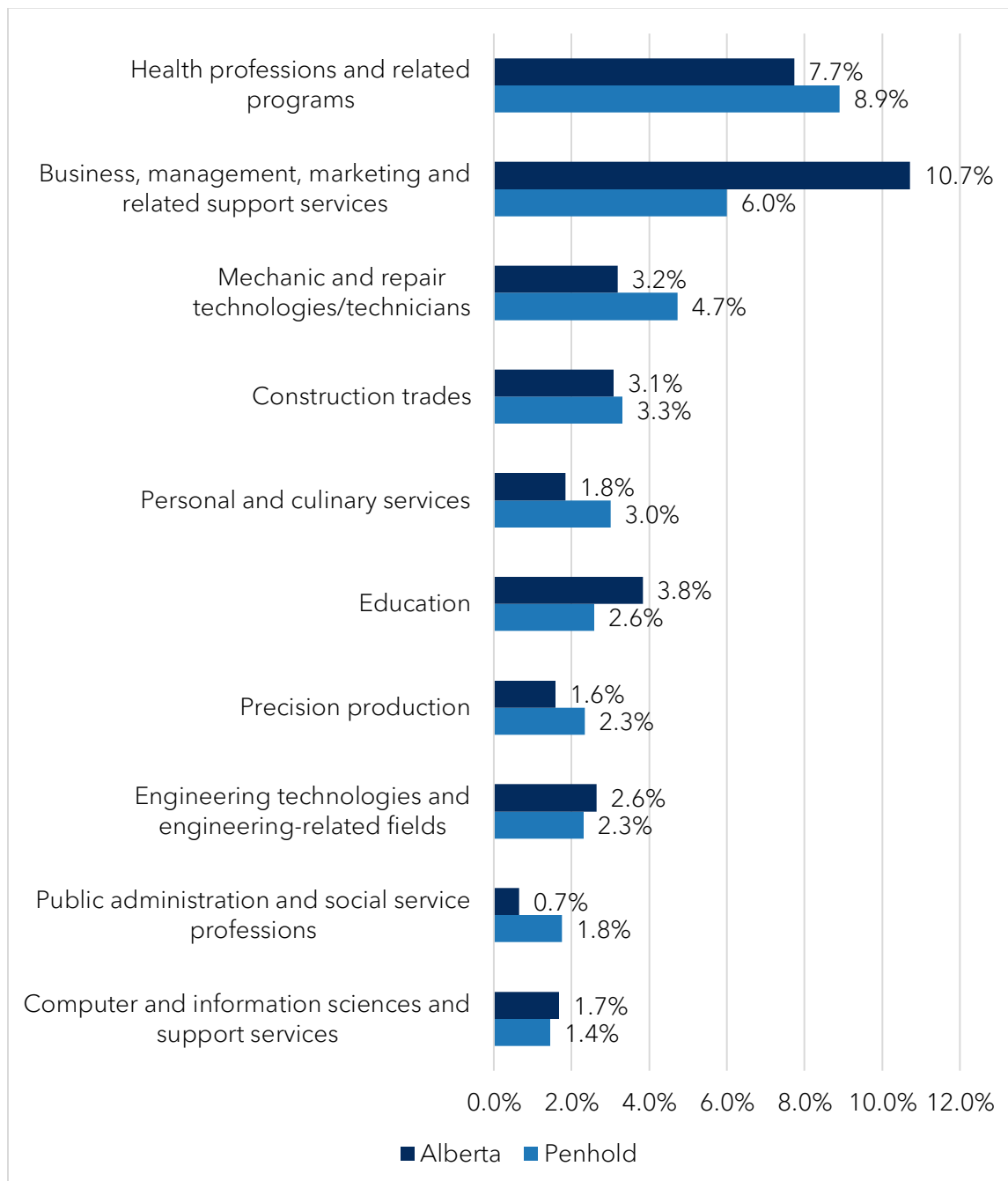

Figure 6 and Table 9 illustrate major subfields of study for residents ages 15 years and older. The two most heavily represented fields of study among Penhold residents are 'health professions and related programs' (8.9% of residents) and 'business, management, marketing and related support services' (6.0%).

When further breaking down major field of study for residents in the Town of Penhold by sex it becomes clear that there are significant differences in fields of study undertaken. Notably, males over 15 in Penhold are much more likely to have studied *architecture, engineering and related technologies*, while females were much more likely to have pursued educational training in *health and related fields* or *business, management and public administration*.

3. LABOUR FORCE

3.1. Key Indicators

The Town of Penhold is home to a labour force of **approximately 2,102 individuals**. As illustrated in Table 10, participation, employment, and unemployment rates are all comparable to provincial marks. This suggests that residents are both engaged in the labour force and finding suitable employment at comparable levels in Penhold as they are across the province.

Penhold's youth are more likely than youth across Alberta to be engaged in the labour force (74.74% of youth in Penhold are participating in the economy, compared to 64.41% across Alberta). They are also more likely to be working (55.66% employment rate compared to 50.52%), Though the local unemployment rate is slightly higher than the provincial mark (25.52% compared to 21.57%) that is likely due to more youth participating in the economy, and therefore looking for work.

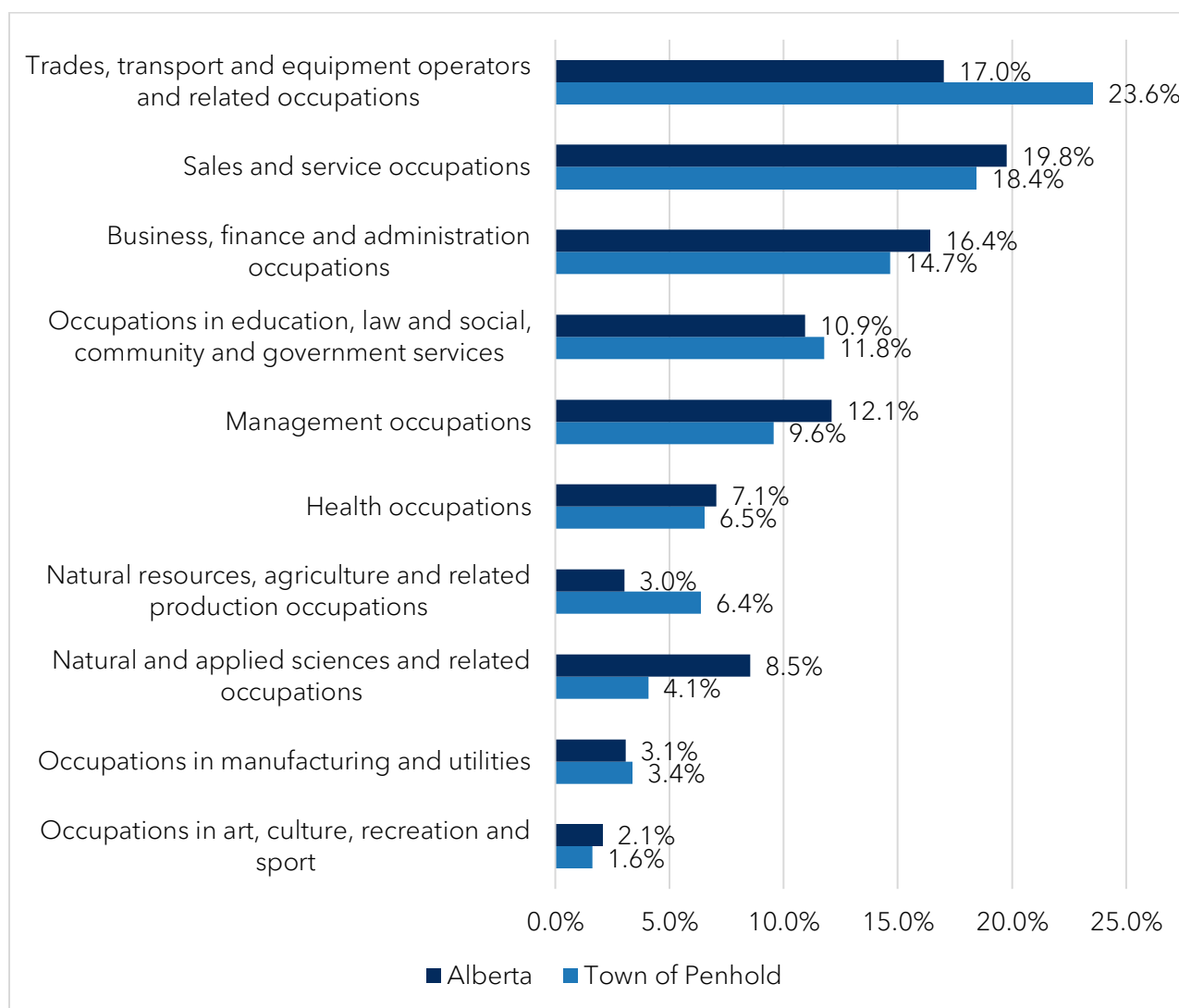


3.2. Labour Force by Occupation

Figure 7 and Table 12 illustrate Penhold's labour force make up by occupation:

- 'Trades, transport and equipment operators and related occupations' are the largest occupation group (23.6% of residents work within this occupation class) in Penhold.
- 'Occupations in art, culture, recreation and sport' are the least intensive in Penhold, representing 1.6% of occupations, slightly less than the provincial mark (2.1%)

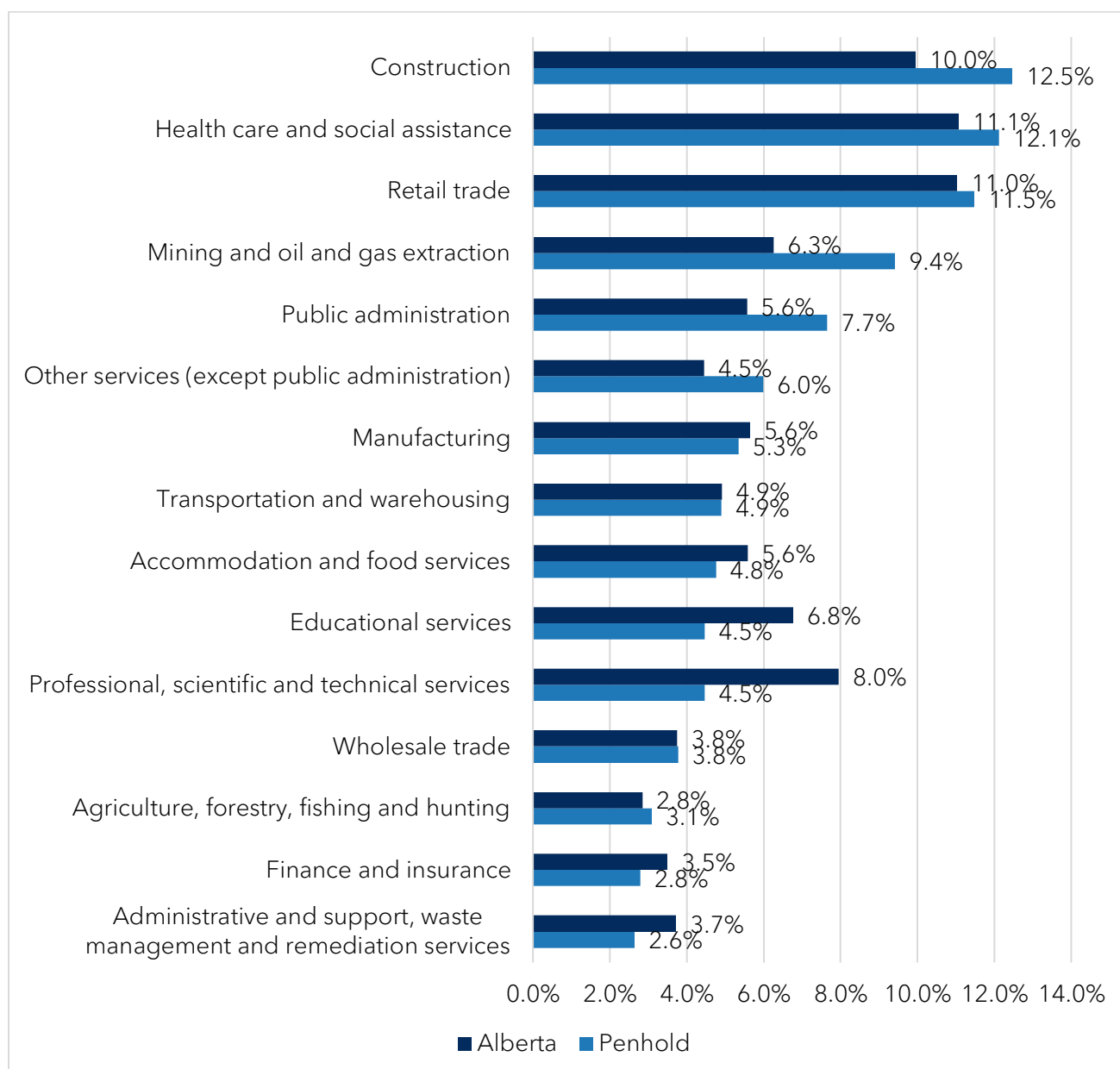

3.3. Labour Force by Industry

Figure 8 illustrates the top 15 employment sectors in Penhold. Penhold's sector distribution is fairly similar to the provincial breakdown. That is, 'construction' locally represents 12.5% of all jobs, compared to 10.0% at a provincial level. Similar distribution is seen in 'health care and social assistance' (12.1% locally and 11.1% at a provincial level) and 'retail trade' (11.5% and 11.0%).

4. QUALITY OF LIFE

4.1. Housing Characteristics

Houses in Penhold were relatively affordable in 2022, with average and median dwelling values both under \$500,000. Additionally, Penhold residents have strong home ownership rates, with more than 4-in-5 households (85%) owning the dwelling they are living in. Finally, only 17% of the population spends 30% or more of household total income on shelter costs (a traditional measure of household affordability). This compares favourably to rates across the rest of Alberta (also 17%).

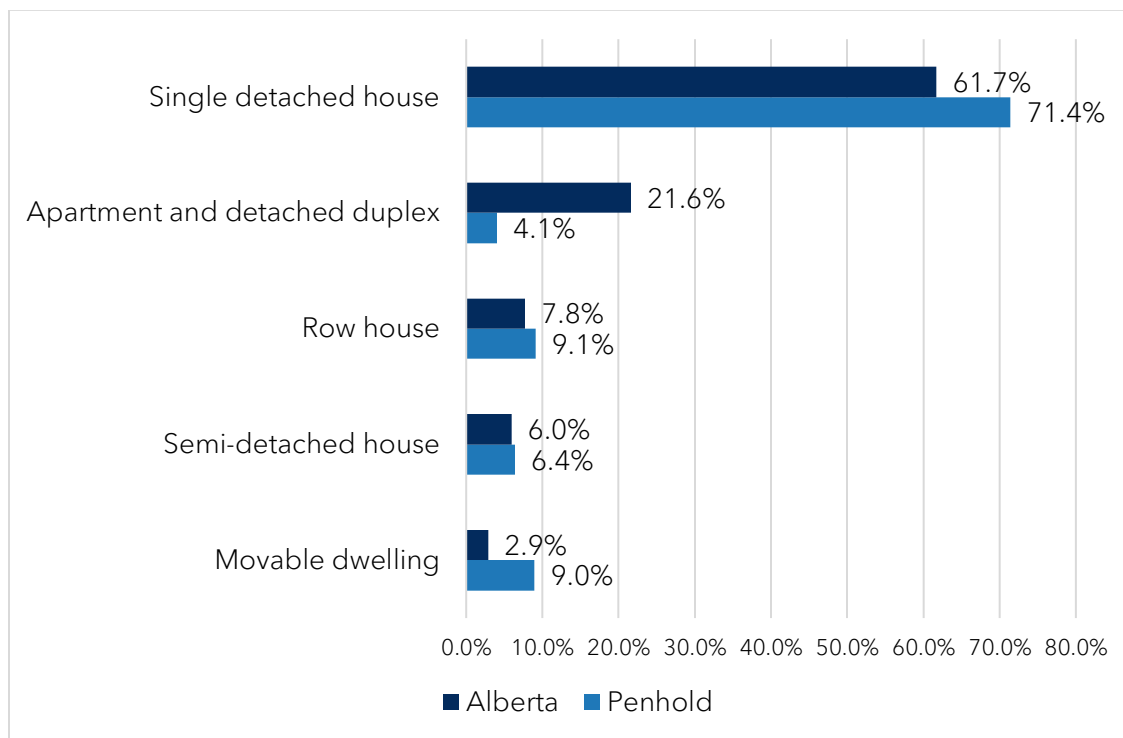

Penhold has more single detached homes compared to Alberta (71.4% of housing units are single detached homes in Penhold, compared to 61.7% across Alberta) and movable dwellings (9.0% compared to 2.9% across Alberta). The Town correspondingly has significantly fewer apartments (only 4.1%, compared to 21.6% provincially), but comparable levels of row houses (9.1% to 7.8%) and semi-detached homes (6.4% to 6.0%).

Penhold is situated between several major highways including Highway 2A, Highway 42 and Highway QEII. Highway QEII is the main North-South Highway in Alberta, which provides access to both the Southern border, known as the Canamex Trade Corridor, linking Canada to Mexico through the United States, and its tidewater, linking Canada to East Asia markets.

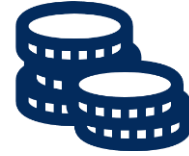
